



## BID NOTICE AND INVITATION TO BID

Tenders are hereby invited from suitably qualified contractors for **GARIEP DAM: REFURBISHMENT OF WATER TREATMENT WORKS** under Kopanong Local Municipality. Qualified contractors are those that have a **CIDB** grading designation of **3CE PE** or **4CE** or higher for civil, mechanical and electrical works with similar specialist experience with a proven track record.

**Tenderers must note that certain works under this tender may only be constructed using labour based construction methods and must limit the utilisation of their permanently employed personnel to key personnel and all other personnel and labourers must be recruited locally.**

Tender documents will be available as from **Wednesday 10, April 2013** during office hours from the Municipal Offices at 23 Van Riebeeck Street, Trompsburg 9913, at the Project Management Unit (PMU). A non-refundable cash payment of **R250-00 per document** is required on collection of the tender documents.

A compulsory briefing with representatives of the Employer will take place at the Municipal Offices in **Gariiep Dam, 3 Patrys Street** on **Wednesday 10, April 2013** starting at **10h00 am**. A person who is suitably qualified and experienced to comprehend the implication of the work involved must represent the tenderer at the site inspection.

Tenders will be closed on the **Friday 19, April 2012 at 12h00 pm**, and after which will be opened to public. No tender document will be available after **Friday 12, April 2013**. Telegraphic, telephonic, telex, facsimile and late tenders will not be accepted. Completed tender documents clearly marked **"GARIEP DAM: REFURBISHMENT OF WATER TREATMENT WORKS BID NO. KLM/GDWTW/04/2013"**, in **sealed envelopes** must be deposited in the Tender Box of Kopanong Municipality, at 20 Louw Street Trompsburg.

Tenderers should take note of the following tender condition:

1. **No bids will be accepted from persons in the service of the state.**
2. No telegraphics, telefaxes and late Bids will be accepted.
3. Municipality is not bound to accept the lowest Bid, as part of any Bid.
4. Failure to complete all supplementary/requested information will result in the Tender being deemed null and void.
5. Tenderers are to familiarise themselves fully with the Specifications and other portions of the Tender Document.
6. Tenderers must submit a Valid Original SARS Tax Clearance Certificate or in the Case of a Joint Venture, Tax Clearance Certificates of All Partners in the Joint Venture with their Tender in order to be considered.
7. Tenders will be evaluated based on the Preferential Procurement Policy of the Municipality using the 90/10 points system. B-BBEE certificate is compulsory to qualify for preferential points. The lowest or any tender will not necessarily be accepted and the Municipality reserves the right to accept any tender wholly or partially.
8. Should you not receive any correspondence from us within 90 days from the date of closing of tender regard your bid as unsuccessful.
9. Communication will be limited to the successful bidder.
10. Bidders will also be subjected to screening process.
