BID NOTICE AND INVITATION TO BID

Tenderers are hereby invited from suitably qualified contractors for, **PHILIPPOLIS: CONSTRUCTION OF 2km PAVED ACCESS ROAD MIG/FS0903/R, ST/12/13** in Philippolis, under Kopanong Local Municipality. Qualified contractors are those that have a **CIDB** grading designation of **5CE PE** or **6CE** or higher for civil work with similar specialist experience with proven track record.

Tenderers must note that certain works under this tender may only be constructed using labour based construction methods and must limit the utilisation of their permanently employed personnel to key personnel and all other personnel and labourers must be recruited locally.

Tender documents will be available as from **Monday 22 October 2012** during office hours from the Municipal Offices at 20 Louw Street, Trompsburg 9913, at Supply Chain Management Unit. A non-refundable cash payment of **R500-00 per document** is required on collection of the tender documents.

A compulsory briefing with representatives of the Employer will take place at the Municipal Offices in Trompsburg, on **Wednesday 24, October 2012** starting at **10:00**. A person who is suitably qualified and experienced to comprehend the implication of the work involved must represent the tenderer at the site inspection.

Tenders will be closed on the **Friday 2, November 2012 at 12:00**, and after which be opened in public. Telegraphic, telephonic, telex, facsimile and late tenders will not be accepted. Completed tender documents clearly marked "**PHILIPPOLIS: CONSTRUCTION OF 2km PAVED ACCESS ROAD MIG/FS0903/R, ST/12/13**", in **sealed envelopes**, must be deposited in the Tender Box of Kopanong Municipality, at 20 Louw Street Trompsburg.

Tenderers should take note of the following tender condition:

1. Failure to complete all supplementary/requested information will result in the Tender being deemed null and void.
2. Tenderers are to familiarise themselves fully with the Specifications and other portions of the Tender Document.
3. Tenderers must submit a Valid Original or Certified Copy of The Company's SARS Tax Clearance Certificate or in the Case of a Joint Venture, Tax Clearance Certificates of All Partners in the Joint Venture with their Tender in order to be considered.
4. Tenders will be evaluated based on the Preferential Procurement Policy of the Municipality using the 90/10 points system. B-BBEE certificate is compulsory to qualify for preferential points. The lowest or any tender will not necessarily be accepted and the Municipality reserves the right to accept any tender wholly or partially.
